Section 4 First Aid Measures

Emergency and First Aid Procedures

Inhalation: In case of accident by inhalation: remove casualty to fresh air and keep at rest.

Section 6 Spill or Leak Procedures

Steps to Take in Case Material Is Released or Spilled:

Exposure to the spilled material may be irritating or harmful. Follow personal protective equipment recommendations found in Section 8 of this SDS. Additional precautions may be necessary based on special circumstances created by the spill including; the material spilled, the quantity of the spill, the area in which the spill occurred. Environmental Precautions:

Avoid breathing material. Avoid contact with skin and eyes. Prevent the spread of any spill to minimize harm to human health and the environment if safe to do so. Wear complete and proper personal protective equipment following the recommendation of Section 8 at a minimum. Dike with suitable absorbent material like granulated clay. Gather and store in a sealed container pending a waste disposal evaluation.

Handling: Wash thoroughly after handling. Avoid release to the environment. Wear protective gloves/protective clothing/eye protection/face protection. Avoid direct sunlight and heat. After contact with skin, wash immediately with plenty of water.

Storage: Keep container tightly closed in a cool, well-ventilated place.

Storage Code: White - Corrosive. Separate acids from bases; separate oxidizer acids from organic acids.
